#### **Dr. Caryl Burbank, Practiced Medicine Here Half Century**

Dr. Caryl Burbank, 75, who would have completed 50 years of medical practice in Washington on February 1, died unexpectedly on Monday.

Dr. Burbank was in Rockville on business when he collapsed on a parking lot. The Rockville Rescue Squad administered oxygen, but he was pronounced dead on arrival at Suburban Hospital, Bethesda. He lived at 3813 Legation street N.W. and had offices at 1801 I street N.W. He specialized in internal medicine.

Dr. Burbank was born in Washington, the son of Daniel Norman Burbank, Washington attorney. He was graduated from Georgetown University Medical School in 1903 and interned the following two years at Garfield Hospital. He was formerly resident physician at Garfield and an internist at Freedmen's from 1908 to 1932.

He was associate professor of medicine at Howard University from 1908 to 1935, and during World War I he was medical examiner for draft inductions. He was also chief medical examiner for the American Red Cross during World War I.

During World War II, Dr. Burbank was a member of the Medical Advisory Board C, Selective Service System.

Since 1929, he had been a member of the Board of Examiner in Medicine and Osteopathy of the District Commission on Licensure.

He was a life member of the District Medical Society and a fellow of the American Medical Association.

Survivors are his widow, the former Helen Fitz of Lynn, Mass.; a son, Dr. Daniel N. Burbank, Cedar Grove, N.J., and two grandchildren.

Services will be held at 2 p.m. tomorrow in Hysong's Funeral Home, 1300 N street N.W. Burial will be in Congressional Cemetery.

#### **Dr. Burbank; Practiced in D.C. 50 Years**

Dr. Caryl Burbank, 75, of 3813 Legation st. nw., who practiced medicine in Washington for nearly half a century, died of a heart attack Monday while on the way to a call in Rockville, Md.

Dr. Burbank was a member of the District Board of Examiners in Medicine and Osteopathy, which he served for more than 20 years.

A native of Washington, he graduated from Georgetown University Medical School in 1903 and did his intern work at Garfield Hospital. He was an associate professor of medicine at Howard University from 1908 to 1935.

In World Wars I and II, he served on examining boards passing on the condition of candidates for induction into the armed forces. He was a member of the American Medical Association and the District Medical Society.

Surviving are his wife, Helen Burbank; a son, Dr. Daniel N. Burbank, of Cedar Grove, N.J.; and two grandchildren.

Services will be held at 2 p.m. Thursday at Hysong's funeral home, 1300 N st. nw. Burial will be in Congressional Cemetery.
