Victor C. Kracher, 71, former manager of the Manor Country Club and the Washington Golf and Country Club, died Wednesday at Holy Cross Hospital after a short illness.

For the past 25 years Kracher had been in country club management in this area.

Born in Vienna, Austria, he moved to London at the age of 17. After World War I he came to Canada and started in hotel work there.

Kracher moved to Montgomery County 39 years ago. Since then he had served as manager of the Oak Crest Club, the Arlington club and the Manor club located in Norbeck, Md. For the past eight years he worked at the Columbia Country Club.

For some time he had been manager of the Madison Arms Banquest Center.

He was a member of the National Capital Club Managers Association.
