C.T. Milans Dies; Patent Attorney Native of Capital Succumbs at 53 After Long Illness

Calvin Tarkington Milans, 53, prominent patent attorney, died at National Homeopathic Hospital yesterday after a long illness. He was a native of this city, the son of Joseph D. Milans, who was in the printing and publishing business here for many years.

Mr. Milans attended the public schools here and Columbian CALVIN TARKINGTON MILANS, College, now George Washington University, from which he received degrees of bachelor and master of laws and master of patent law. On his graduation, he entered practice with his brother, Joseph H. Milans, and the firm has been in offices in the McGill Building since. His home is at No. 8 Chamberlin avenue, Kenwood, Md.
