Struck By Car

Albert Reese Sustains a Fracture of the Skull

Albert Reese, fifty-five years of age, who has been in the employ of the Capital Traction Company for several years, was struck by a streetcar last night and severely injured. It is stated that he had been enjoying a short vacation and was near the river front conversing with a number of friends. When he left them and started to go to his home, 552 M street southwest, he passed in the rear of one car and was struck by a car going in the opposite direction. Mr. Reese was thrown several feet from the car and injured about his head.

When Mr. Reese reached the Emergency Hospital the surgeons found that he had sustained a fracture of the skull and that his condition was serious. Relatives called to see him. When his brother visited the institution this morning the patient was unconscious.

Death Of Albert Reese

Coroner Will Hold Inquest to Fix Responsibility

Coroner Nevitt will hold an inquest at the morgue tomorrow morning at 11 o'clock in order that a jury may pass upon the death of Albert Reese, fifty-five years of age, who died at the Emergency Hospital last night. Ten days ago he was at the 7th street wharf conversing with friends, and when he started toward his home on M street near the river he was strck by a streetcar and injured. It was reported by the police that he walked in the rear of one car and was struck by a car going in the opposite direction. He was thrown a considerable distance and his skull was fractured.

The injured man was removed to the Emergency Hospital, and his condition was regarded as critical. Many relatives and friends called at the hospital to see him during the ten days he was under treatment. The physicians did all they could for him, but they were unable to save his life. Mr. Reese had been in

the employ of the Capital Traction Company for a number of years, and was enjoying a short vacation at the time he met with the accident which ended his life.

Company Exonerated Coroner Investigates Circumstances Attending Death of Albert A. Reese

An inquest was held at the morgue today to fix the responsibility for the death of Albert A. Reese, the Washington Railway and Electric Company car starter, who was struck by a car of the Capital Traction Company on Water street near N street Tuesday, May 1, and who died from his injuries at the Emergency Hospital May 7. The inquiry opened at 11:30 o'clock before Coroner Ramsay Nevitt, and the jury, after hearing the evidence, brought in a verdict of accidental death and exonerated the street railway company.
